


Building Endowments for the Future of Our Communities Through Gifts That Keep On Giving

It was time to celebrate recently as many supporters, donors, local dignitaries, grant recipients and past and present board members gathered at the new Sparrow Ionia Hospital to mark the 20th Anniversary of the Ionia County Community Foundation.

"This evening is all about saying thank you to all of you for your wonderful generosity and support of ICCF through the years," noted President Jim McCarty. "Starting with \$1,000 in seed money, co-founders Ron Story and Mike Magee established ICCF in the fall of 1995 and then helped nurture and



watch its phenomenal growth over the next two decades."

"Today," continued McCarty, "the market value of assets is over \$7,000,000 with nearly 30 component funds under the foundation's large and getting larger umbrella. What's more, over \$3,000,000 in grants and scholarships has been awarded to non-profit partners throughout the County."

"This is a very proud night for us," said Story who served as President for the first 14 formative years. "It was just a dream early on but now we can truly say that it is a dream that has come true as

ICCF Makes Major \$50,000 Grant to Sparrow Ionia Hospital

Ionia County Community Foundation is pleased to have made its first \$10,000 annual installment of its five year \$50,000 pledge to the new Sparrow Ionia Hospital. According to ICCF President Jim McCarty, "the ICCF board believes the beautiful new stateof the-art health care facility will be a tremendous asset to the county and the surrounding area."

"ICCF is excited to partner up with Sparrow by pledging significant funds to help make this major project possible," continued McCarty. "This is a special milestone year for ICCF as we are celebrating our 20th year anniversary. This gift to the new hospital, which will provide quality health care for generations to come, seems very appropriate in keeping with our mission that what we do is "For Good. For Ever."

The grant to Sparrow Ionia Hospital

is the second impact grant approved by the ICCF. The first one supported the Ionia County Economic Alliance/Right Place partnership that has resulted in significant job creation, retention, expansion and capital investment and workforce training.

During the years, ICCF has awarded \$700,000 to non-profits throughout Ionia County. When all 23 component funds under the ICCF umbrella are considered, more than \$3 million has been awarded for grants and scholarships.

"We are very grateful," said McCarty, "to all who contribute philanthropically to our endowment program to make a positive difference in the lives of the citizens of Ionia County."

Commenting on the latest ICCF gift, Jason Eppler, President of the Sparrow Ionia Hospital Foundation said: "The Ionia County Community Foundation has done it again – demonstrating that it cares deeply for those who reside and work in Ionia County by being a major donor toward the construction of the new Sparrow Ionia Hospital. ICCF and its directors and donors recognize the role that modern health care plays in supporting the quality of life that we enjoy in Ionia County. On behalf of the Hospital Foundation, I sincerely thank ICCF for its generosity, vision and commitment to a healthy Ionia County."

ICCF ACCEPTING GRANT APPLICATIONS FOR \$35,000

The Ionia County Community Foundation is now accepting applications for its twentieth annual grant-making round. According to Grant Committee Chairman Brian Talbot, "\$35,000 in funds are available for distribution to nonprofit organizations throughout the county."

"We are encouraging county organizations with 501(c) 3 Internal Revenue Code tax exempt status to submit an application by going on line at www.grfoundation.org/Ionia", noted Talbot. "In order to be eligible for the grants to be announced no later than March 31, 2016, applications must be submitted on-line by December 31, 2015."

"We are excited to be able to place so many dollars where they can best serve the needs of our neighborhoods," continued Talbot. "It is the essence of what the Ionia County Community Foundation is all about."

Advisory Committee Chairman Jim McCarty commented that this latest grant-making cycle will bring our total allocations from our unrestricted funds to over \$700,000 since the ICCF endowment program was established in the fall of 1995 – 20 years ago."

And...when the other 27 component funds under the ICCF umbrella are included, the aggregate amount of distributions into the county is over \$3 million.

Each year, the money available for grants is 5% of the endowment's average market value of assets for the previous 16 quarters. This allows the asset base to grow while helping meet the cultural, educational, recreational and economic needs of Ionia County. Grants are not available for general operating expenses, annual fund raising drives or debt retirement. They are available for projects that:

- represent an innovative, start-up effort or are capital in nature (e.g., bricks and mortar, equipment)
- promote cooperation among agencies without duplicating services
- need additional funding to implement and maintain projects
- strengthen or improve agency self-sufficiency or efficiency
- yield substantial community benefits for the resources invested
- serve a broad segment of the community
- encourage additional and permanent funding or matching gifts from other donors

Applications will be reviewed by the ICCF Grants Committee and approved by the Fund Advisory Committee. They will be evaluated on program needs, effectiveness, clarity of focus and goals, degree of risk and other criteria. Once again applications are available on the ICCF website at www.grfoundation.org/Ionia and must be submitted by December 31, 2015. Questions should be directed to Brian Talbot at (616) 527-8721.



Ionia County Community Foundation welcomes two new board members

The Ionia County Community Foundation Board recently welcomed **Jason Mellema** of Portland and **Hailie Patterson** of Ionia as two new members of its advisory board.



Mr. Mellema assumed the role of Superintendent at the Ionia County Intermediate School District (ICISD) in July; he served as superintendent of Pewamo-Westphalia Schools from 2011 to 2015. Previous educational positions included diverse administrative roles at Ravenna from 2004 to 2011 and teacher at Holton Schools from 2002 to 2003.

Mr. Mellema earned his Bachelor of Arts degree in Education from Hope College, his Master of Art degree in Sport Administration from Central Michigan, and is currently enrolled in the Educational Leadership Program at CMU.
